#### INTRODUCTION

Chairperson Ross introduced three new employees: Ms. Karen Kwandrans, Assistant Vice President of Academic Affairs, Workforce Development, Mr. Terry Gill, Assistant Chief Campus Public Safety/Peace Officer, and Mr. Wayne Lynch, Interim Vice President of Operations. Chairperson Ross welcomed these new employees to the college campus and wished them well.

# **CHAIRPERSON'S REPORT**

Chairperson Ross stated the November 9 Veterans Day ceremony was very well organized and attended. Special thanks to Joe Colosi for a job well done.

Chairperson Ross provided a brief update on the Presidential Search; The search committee is in place and the first meeting will be held on Tuesday December 18 from 2:00 – 5:00 p.m. at the Niagara Falls Culinary Institute. At this time, Chancellor Johnson will provide the search committee and the search firm with the charge to begin the process of a presidential search for our college. This will set the foundation for the presidential search.

Chairperson Ross thanked Trustee Sloma for attending the ACCT Conference held in New York City at the end of October. Trustee Sloma provided information on a topic of conducting a presidential search. ACCT recommends college boards need to define the profile of the candidate of what will fit for the college. Trustee Sloma recommends a retreat to define what the board is looking for in qualifications and characteristics of the new president. Dr. Murabito stated he would reach out to a college president to possibly facilitate this retreat. Chairperson Ross stated the December board meeting was changed to December 11 and at this time could further define what the board is recommending in a new president

Dr. Murabito discussed the following:

- Welcomed the three new employees and provided more background information for each.
- Trustee Vincent Ginestre gave his resignation from the board effective October 19 and thanked Vince for his commitment and dedication to the college.
- We have recently received full accreditation for our Surgical Technology Program. Thank you to all those who lead this process.
- Brian Michel, Director of Grants provided an update on the National Science Foundation. We are
  one of 20 colleges nationwide selected to be a part of a cohort called Mentor Connect which is
  part of the National Science Foundation. Special thank you to Lydia Ulatowski for bringing this
  opportunity forward.
- The annual holiday boards' dinner/meeting will be on Tuesday December 4; please provide your RSVP to Barb Walck.
- The December board meeting will be on Tuesday December 11.
- The Foundation Gala was very successful this year, with over 300 attendees. Trustee Wolfgang passed along that Niagara University attended the distinguished student recognition earlier in the evening. Niagara University was very impressed with the student presentation and duplicated the video presentation during their president's dinner. Trustee Wolfgang also discussed how NU provided another way of raising funds with a donation card on the dinner tables.
